Signature above constitutes member’s agreement to the following terms and conditions:

1. To comply with and be bound by Redhill Forest Regulation 16-2 rev 3 “Redhill Forest Fishing Regulations with Violation Process” and any subsequent revisions approved by the Board during the year;
2. To confirm they are included on the Authorized Fishing Member List available at [Fish/Hunt/Camp | Redhill Forest \(redhillforesthwa.com\)](https://fish/hunt/camp|redhillforesthwa.com) prior to entering any Fishing Area;
3. To provide their lot number, full name, and valid CO fishing license when asked to verify approved access to any Fishing Area;
4. Consent to be photographed by the automated cameras located at each Fishing Area sign-in;
5. Acknowledgement that all Fishing Areas are fly fishing only, i.e., fly rods and tackle only; and
6. Any information necessary to process this application, including member standing in the Association, may be shared with the Board, Fishing Committee, Ranch Owners, and their respective counsel.

**Instructions:**

- By checking “Renewal Application” above, you are confirming no changes to the information contained in your 2023 application, including no changes to your deed, no additions or changes to members requesting fishing access, etc. Renewal applicants should complete the section above and provide payment information and mailing address below when submitting this form. No additional photos, second forms of identification, etc. are required.
- Email the completed form and attachments to [fishing@redhillforest.org](mailto:fishing@redhillforest.org).
- Attach one current high-resolution photo per each member listed above.
  - Head and shoulders only, e.g., passport, professional headshot, or mugshot style photos.
    - No photos with hats, hoods, or sunglasses or group or full body photos will be accepted as this can obscure the identity of the member and greatly increases processing time.
  - This photo will be posted publicly in the online database available at [Fish/Hunt/Camp | Redhill Forest \(redhillforesthwa.com\)](https://fish/hunt/camp|redhillforesthwa.com).
- Attach a copy of a second form of photo identification, e.g., driver’s license, passport, etc., per each member listed above. This will be used to verify identity of the member but not posted publicly in the online database.

- Fee simple deeded member status will be verified by:
  - A Fishing Committee member confirming current owner(s) listed at the Park County Assessor's Property Search detail available at <https://www.parkco.us/73/Assessor>; and
  - Member(s) attaching a copy of their property deed with this form.
    - Generally acceptable deeds are general warranty, special warranty, bargain and sale, and treasurer's deeds.
    - Quitclaim and other deeds that do not necessarily convey a fee simple ownership interest will need to be supported by additional information demonstrating appropriate chain of title.
    - Deeds and other records can be accessed online for a fee at the Park County Online Document Search at: <https://www.parkco.us/555/Online-Document-Search>.
  - If the name(s) appearing on the deed does not match the Park County Assessor's Property Search detail or the name(s) is not a natural person(s), additional information may also be required.
  - Members who own their lot through a limited liability company, partnership, corporation, or other form of legal entity (other than grantors of a revocable living trust or similar legal entity) will not be considered or approved.
